  - (a) To review and monitor the technical and financial progress of the respective Projects and the Scheme from time to time till the completion of the scheme;
  - (b) To provide necessary technical expertise and guidance for the successful implementation/ completion of the projects/Scheme;
  - (c) To consider and recommend re-appropriation of funds among different heads of the projects as per extant rules, if required;

- (d) Examine the report on Mid-term Appraisal of the project in the fourth year of the implementation and recommend mid-course corrections, if any required, after taking in to account various aspects for ensuring continuity/sustainability of the Academy; and
- (e) Any other issue connected with the implementation of the scheme.
- 4. The TA/DA for attending the meetings of the PRSG shall be payable as per Government norms.
- 5. As the PMU for the above scheme is being implemented by NIELIT, the technical secretariat of the PRSG shall be maintained by NIELIT.
